Socialization Walks

Socialization walks are open to students / clients of ABC Dog Training LLC at no charge.¹ The following rules must be followed by all participants of Socialization Walks:

- Handlers/owners must have a current Release of Liability signed and on file with ABC Dog Training LLC
- All dogs must have proof of current rabies vaccination
- Dogs can either be off-leash or dragging a long line – no leashes allowed
- Handlers must wear sturdy shoes or boots as the ground surface can be muddy, uneven, etc. Long pants are highly recommended.
- Walks begin promptly at the scheduled time – the gate will be unlocked a half hour prior to the scheduled Walk. Latecomers will not be allowed so please be on time.

Socialization walks are conducted in a rural area where there are skunks and other wildlife. Please be aware that there are risks associated with having your dog off leash in this environment. It is recommended that you wear sunscreen and bug repellent as necessary and that your dog be thoroughly checked for ticks or foreign matter stuck between toes, etc. after every walk.
